SPECIFICATIONS FOR GRAVEL AND SAND**

- (1) General: It is the intent of this bid to provide a comparative basis for the purchase of gravel and sand by the City of Salem through April 30, 2018. The City shall have the right to accept or reject any or all bids, may accept a bid other than the lowest bid if it is in the City's best interest, and shall have (30) thirty days within which to accept or reject any bid.
- (2) Estimated Quantities:
 - a. 1,000 ton CA-6 rock
 - b. 200 ton FA-1 sand
- (3) The City of Salem will periodically issue purchase orders for the delivery of rock and sand. Delivery shall be at the request of the City.
- (4) Delivery Point: City of Salem Maintenance Garage in Tully Park off North Shelby Street.
- (5) All bids shall be submitted on the attached form.
- (6) Quantities are estimated only, and in no way commit the City to purchase either a minimum or maximum amount.
