#### City Council Action -

- 2. The planning Commission has met and reviewed the Special Use Permit request from Keith McNeil for proposed activities at the Orchard Shopping Center on Friday Nights and Saturday evenings from 5:30 pm to 9:00pm. This is a temporary Special Use Permit and is good for one year from the issuance of the permit. Events could include live music by local talent or tenants of the shopping center. Their first event is tentatively scheduled for August 7<sup>th</sup> pending Council Action. Recommend approval.
- 3. Change order to accommodate repairs on North Illinois Street amounting to \$32,280.00 to repair the sewer line collapse along with payment request # 2 on the replacement of sanitary sewer and water lines on West Whittaker The pay request includes both project amounts totaling \$53,228.22 and leaves a retainage of \$8,679.02 or 5% of the project totals. Work has been completed. Request approval.
- 4. The City is the named administrator for the Grant application with the IL Dept of Natural Resources through the OSLAD program. The Agreement needs to be approved by the Council and signed off to be returned to IDNR to move the project along. The local group has raised the matching funds necessary to complete the project. Upon the submission and acceptance of the grant agreement to IDNR, we will be sending bid requests to vendors as the next step in the project process. Request approval to remit the grant agreement.
- 5. The City has surplused the property at 112 S. Broadway currently know as Centennial Park. The tract is located between Kane Insurance Agency and the ABC Pub. Sealed bids are to be opened at the public meeting. Bids may be discussed in executive session if desired with any acceptance or rejection being noted after the executive session.
