**October 3, 2022**

- I. CALL TO ORDER**

The regular October 3, 2022, meeting of the Salem City Council was convened in the Council Chambers of Salem City Hall. The meeting was called to order by Mayor Nic Farley at 6:00 pm.

- IV. MAYOR’S REPORT AND PRESENTATIONS**

Mayor Farley gave a big “thumbs up” to the organizers of the Little Egypt Festival, and added that the event had great attendance, and the City actually ran out of candy. Farley expressed appreciation to the Public Works Department, DOEM, and Salem Police Department for their coordination with the Committee.

Mayor Farley indicated the Historic Tour of East Lawn Cemetery was great, and had some fantastic orators. Farley added a “hats off” to Cemetery employee Nick Savin. Farley added that there were also a rodeo and demo derby in the area, and all the activity made him proud to be Mayor.

V. **CITY COUNCIL ACTION**

1. **Consent Agenda**

- a) Approval of Minutes – September 19, 2022

***Motion was made by Councilwoman Trout and seconded by Councilman Bringwald to approve the minutes of September 19, 2022, as presented. Roll call vote: AYES: Councilman Bringwald, Councilwoman Troutt, Councilman Morton, Mayor Farley. NAYS: None. Motion carried.***

2. **Approval of Appointments to Boards and Commissions**

Mayor Farley indicated he would like to appoint Brad Crow to the Library Board and Brooke Frederick to the Tourism Board, with City Council’s approval. Mayor Farley added that while he doesn’t usually appoint City employees to serve on city boards or commissions, but he did some checking and there does not appear to be any conflict with Mr. Crow serving as a Telecommunicator for the Police Department and serving on the Library Board. Mayor Farley added that Ms. Frederick works for SCIRPDC, and just wants to give back to the community.

***Motion was made by Councilman Bringwald and seconded by Councilwoman Troutt to approve the appointments of Brad Crow to the Library Board and Brooke Frederick to the Tourism Board. Roll call vote: AYES: Councilwoman Troutt, Councilman Morton, Councilman Bringwald, Mayor Farley. NAYS: None. Motion carried.***

3. **Recognition of Retirement of K-9 Officer Freddie from the Salem Police Department**

Mayor Farley presented a video of K-9 Freddie’s last radio call, announcing that he is 10-42 (*retired*), and presented Officer Dustin Duncan and K-9 Freddie a certificate of appreciation for their service as the Salem Police Department’s K-9 Team.

VI. **CITY MANAGER AND DEPARTMENT HEAD REPORTS**

City Manager Barbee -

- thanked the Public Works Department for their work in placement of the detour signs over the busy weekend and offered kudos to the Historical Commission and the Cemetery Staff for their efforts with the East Lawn Cemetery Tour;
- thanked Councilman Morton, Councilman Bringwald, Councilwoman Troutt and Mayor Farley for walking in the parade;
- indicated the theatre board will be doing some maintenance on the marquee next week, and there will be some blocking of the sidewalk;
- indicated Ameren has relocated the power pole on Whittaker, so the project can proceed;
- indicated he and Dir. Sola met with Jim Koerner of NAL and with Citation Oil.

Public Works Dir. Sola –

- indicated the power pole on Whittaker was moved Saturday afternoon, and there will be a power outage to that area of town on Tuesday night.

Finance Dir. Roth –

- indicated the revenue and expense reports will be sent out tomorrow.
