Re: Request for proposal for new loader backhoe

The City of Salem is seeking proposals for a new loader backhoe with allowance for trade of the unit listed below. The proposal for the unit shall be submitted on the dealer's letterhead, including a detailed listing of equipment for each unit proposed. At a minimum, please list the following items: year, make, model, availability, delivery date upon receipt of order, and any features applicable to the decision making process regarding the purchase of this unit, such as, warranty, service availability, etc.

The following specifications shall be used as a minimum guideline for this proposal:

- New loader backhoe tractor, 4 wd, extendahoe
- Min. 90 hp net diesel engine
- Full cab w/ heat & A/C
- Ride control
- 18" & 30" bucket- w/quick change coupler
- 4/1 front bucket
- Trade-in: 2009 Case 580 Super M backhoe/loader  
VIN # N9C526256 w/2920 hours

The unit shall have one full year warranty on all parts and labor, two years on drive train with all repairs to be done at the City of Salem maintenance garage, or exchanged with a comparable loaner. If during warranty period, repairs need to be made at the dealer's location, freight will be at the dealer's expense.

**The dealer is to submit a detailed listing of equipment for each unit proposed.**

Dealers may submit proposals for 1 or more units, as they may feel warrant consideration under these guidelines.

**The proposals will be opened at Salem City Hall on Tuesday, June 12 at 3:00P.**

This purchase must be approved by the City Council and will be presented at the June 18, 2018 City Council meeting. The City of Salem reserves the right to purchase via proposal based upon merits of value, and not cost basis alone, as decided by City Council.
