- 2. Request approval of bid for sidewalk repairs at various locations in the City. Low bid is from KRB Excavation and is below budgeted amount. We have worked with KRB in the past.
- 3. Request for approval of bid on bituminous patch mix for application to City streets this year. Low bid was from General Contractors who has provided similar service in the past.
- 4. Request for approval of bid on purchase of mini excavator for the Gas Dept./ Public Works Department. Low bid comes from Bobcat of East St. Louis. This item meets specs and is below budget. The Bobcat unit has several features as standard equipment that Cat and others were including as add-ons.
- 5. Request approval of adopting unused portion of Gas purchase contract of Frohna MO from PEFA and United Gas Management. This contract has about 6 years remaining before the contract can be opted out of and provides a net \$0.25/MMBTU discount on purchases. Annual usage on contract amounts to 10, 846 MMBTU which represents less than 3% of the annual usage of the City of Salem. Estimated savings over a 12 month period amounts to \$2,711.50. Contract is only available to municipalities.
- 6. Request approval of Ordinance amending the current Golf Cart ordinance to allow the addition of street legal Utility Terrain Vehicles on City Streets after an inspection and purchase of a City Permit and sticker. The attached ordinance tries to reflect the talking points from the prior City Council meeting.
- 7. Approval of Accounts Payable for the time frame of Jan. 20, 2020 through Feb. 14<sup>th</sup>, 2020.
