Mayor's Presentation:

DOEM executive Director Terry Mulvany will have served our community for a period of 40 years on May 21st. Mr. Mulvany has served the community in a multitude of positions and is currently serving in the Department of Emergency Management. This is an opportunity to acknowledge his service to date.

Action Items:

- 2. Melissa Mallow has provided a written summary of the County Health Department statistics on the COVID pandemic and some of the actions the Health Department has taken to prevent the spread of the virus and track information on those who have tested positive. She points out some of the risks for her department in not complying with the Governor's Executive Orders. She also addressed the Illinois Insurance Associations information on possible lack of coverage to businesses that open in defiance of the Governor's Executive Order.
- 3. Local Resident, Brock Waggoner, who addressed the Council at the last meeting ,desires the Council to consider his contention that the Governor's Executive Order is unconstitutional and would like for the City Council to vote to declare the City would go against the Governor's Executive Order and allow all businesses to re-open.
- 4. This is a second reading on the ordinance against feeding non-domesticated wildlife excluding birds and squirrels from elevated feeders and includes the fine structure. Request approval.
- 5. The City of Salem has contracted with AECOM for groundwater database management and compliance reporting activities at the Salem Landfill. The services assist in meeting EPA requirements. The contract cost is \$27,350 per year and is a budgeted item. Request approval to renew the contract.
- 6. The contractor for the sanitary sewer replacement along a portion of Town creek and on North Illinois is requesting pay-out #4 on the project. The work has been completed to the satisfaction of the Public Works Dept. This request is in the amount of \$78,367.51. Request approval.
- 7. The Salem Planning Commission is recommending approval of a Special Use Permit Home Occupation for Andrea McGaughy at 627 North Shelby Ave in Salem to allow offering retail sales from her home. She currently makes clothing, hats, facemasks, bags, curtains and other items and has been selling them on-line. Recommendation to approve but restrict allowing non-family customers to the restrictions of the Governor's Executive Order until it has been lifted.
