- 2. The City's Public Works has a gas line improvement project that covers portions of East Boone street and Hester Estates. The project is budgeted through Fund 17. The cost estimates were sought through bid process with bids being due on May 15, 2020. Three contractors were requested to bid with the low bidder for material costs from USDI in the amount of \$31,469.24. Bids for the construction cost were also sought during the same bid process. Two bids were received with the low bid coming from Kieffer Brothers Construction in the amount of \$247,750.00.
- 3. A suggestion to temporarily reduce or rebate a portion of the liquor license fees for FY 2021 due to the impact of COVID 19 pandemic has been offered. The billings for the renewal at the current rate have already been mailed out for license renewal that takes place on July 1st. Some renewal checks for the normal amount have already received but a rebate could be applied. Current fee structures are attached.
- 4. The State of Illinois moved into phase 3 of the recovery plan on May 29, 2020. The earliest date projected for Phase 4 will be June 26th which is structured to allow for gatherings of 50 or fewer in a confined space. We have contracted with J&M to handle the fireworks display and will need to provide them with notice of any cancellation or postponement. There were also plans to have a band perform at the Bryan Park stage prior to the event and Family Fun Day in the Park activities had also been suggested for the 4th of July, assuming gatherings would have been allowed.
