- 1. Request approval for Council meeting minutes from 06-15-2020 and an amendment to the minutes of 05-18-2020 to include a letter written to the Council.
- 2. Frankie Travis, the general Manager of the Salem Walmart, is requesting permission for their staff to man a fundraiser for the Children's Miracle Network Hospital at the corners of Main and Broadway on Friday July 10<sup>th</sup> and 17<sup>th</sup>. This will be the 33<sup>rd</sup> year that the local Walmart store has operated fundraisers for the Children's Miracle Network. Request Approval.
- 3. We have two groups that are requesting permission to host Disc Golf Tournaments in Bryan Park. The first event is a Glow in the Dark Disc Golf tourney that is requesting permission for July 25<sup>th</sup>. This tourney is being organized to increase interest in the sport and develop a local travel team and possibly a league. The organizers for this event are Melanie Johnson and Brandon Shelton. A second event is planned for later this summer as a fundraiser for CASA. The Mission of the Marion County Court Appointed Special Advocate (CASA) association, together with its national and state members, is to provide court appointed volunteer advocacy for abused and neglected children, and to promote and support such advocacy for a permanent home that is environmentally healthy and safe for children. The CASA tournament will be a daytime event.
- 4. The Salem Planning Commission is recommending approval of a Special Use Permit for the new owner of the property located at 420 N. Broadway, to allow for a tanning salon to operate in the main floor portion that formerly housed the H & R Block office. The remainder of the space will remain as residential apartments.
