- 1. Request approval of minutes from the prior Council meeting of 2-22-2021.
- 2. Metro-Ag Inc. of Breese, IL, has been our contractor for hauling off the residual materials from the Salem Waste Water Plant for several years. The current contract is expiring and they are proposing a new two-year contract to haul off the sludge materials at a cost of \$0.051 per dry gallon is proposed. This represents an increase of .008/gal from the prior contract. Requesting approval.
- 3. The Salem Water Department is requesting the purchase of 6 flushing stations to be placed at the end of existing water line trunks to allow for more economical sampling of water for IEPA requirements. The sampling stations allow the water crews to access the water for sampling at the end of the trunk without opening a hydrant and allows the water to be flushed to remove any build-up of chemicals created when the water pools at the end of the lines, thus creating a more indicative sample. Cost of the six flushing stations with sampling station and accessories totals \$14,846.00. This is a budgeted item for FY 20-21 and is below budget. Suggesting approval.
- 4. Gonzalez Companies LLC has provided a summary of the bids received on the FY 2021 City Street Maintenance proposal from Tuesday, Feb. 23, 2021. The bids requested cover separately, seal coat materials and pea gravel top-coat materials. The low bidder on the seal coat materials was Mike A Maedge Trucking Inc of Highland who bid \$528.00 per ton on 195 tons for a total of \$102,960.00. The seal coat aggregate low bid was provided by Beelman Logistics, LLC of East St. Louis, IL in the amount of \$12.24/ ton on an amount of 2300 ton for a total of \$28,152.00. The combined amounts for the low bids total \$131,112.00 along with \$5,078.00 for engineering is \$3,810.00 below the 2021 budgeted amount of \$140,000.00. Recommending approval of both low bidders.
- 5. Public Works is requesting to surplus a 2014 Vermeer trencher that is no longer in use by the gas department. The mini-excavator purchased recently is more versatile and has an attachment that allows our crews to dig trenches for gas lines. We feel that there is a market for the used trencher.
- 6. Somer Real Estate is to provide a sealed offer on a residential tract at the former Salem Armory site. The bid is to be opened during the regular meeting and discussed. Council can opt to table the offer, accept or reject the offer in open session.
- 7. There is a change order request to the Inclusive Playground area for adjustments in the equipment being placed in the playground area that changes the contract price from \$330,000.00 to \$362,000.00. Payment for the additional cost will come out of the grant funding and the funds raised through the Salem Lions Club and Addy and Friends Fundraising. The committee is also making a request to forego the bid-letting process on additional park equipment for fitness stations, batting cages, and other additions made to the grant application for improving our odds at approval to allow the additional items to be purchased through the selected vendor Hutchinson Design and Recreation and local vendor PW Athletics (Americana) to allow for efficiency in purchasing power and lead time on the equipment.
