2. Swearing in of Tabitha Meador as the new City Clerk and Assistant City Manager.
3. Swearing in of new patrolman Keith Austin Schoreck as the newest member of the Salem Police Department.
4. Review of request by Saved by Amazing Grace to allow them to serve food items at the Men’s Softball League games in Bryan Memorial Park.
5. The property located on the corner of North Pearl and West Olive St. (50’ x 150’) has previously been listed as surplus property and sealed bids are being accepted at Salem City Hall, 101 S. Broadway, by mail, or in person no later than 4:00 pm on June 1, 2023.
The property located at the corner of W. Warmouth and N. College (175’ x approx. 110’) – the asphalt parking lot from Armory structure - has also been previously listed as surplus property and sealed bids are being accepted at Salem City Hall, 101 S. Broadway, by mail, or in person no later than 4:00 pm on Friday, June 16, 2023. Bids should be in a sealed envelope and provide some detail about what the potential purchaser wants to do with the property and when those plans are expected to take place. Bidders are invited to attend the City Council meeting on June 19, 2023 at 6:00 pm where the bids will be reviewed by Council.

Review of proposal from Security Alarm Co. on the equipment and installation costs for cameras near the sand volleyball court and new shelter, on the west side of the creek near the walking trail and upgrade of equipment to handle additional cameras, **recommend approval of the proposal from Security Alarm Co. for cameras in Bryan Memorial Park.**
