I. Call to Order

The regular December 18, 2023 meeting of the Salem City Council was convened in the Council Chambers of Salem City Hall. The meeting was called to order by Mayor Nicolas Farley at 6:00 PM.

II. Prayer and Pledge of Allegiance

Councilman Koehler offered the opening prayer, followed by the Pledge of Allegiance.

III. Presentation of Petitions/Public Comments

- Mr. Louis Daniels, who resides at 327 E. Bryan Street, read a prepared statement that is included in these minutes as 12/18/2023 Attachment 1
 - Mr. Gerald Broom, who resides at 301 Woodland Dr, indicated that he believes Mr. Daniels' statements to be true, as he lives in the neighborhood, and has seen the nuisance behavior exhibited. He further indicated that he did not want "blood on anybody's hands."
 - Councilman Bringwald indicated that he considers the behavior unacceptable and elder abuse. He suggests a nuisance ordinance.
 - City Attorney Jones indicated that this is a sad situation of neighborhood behavior, but elder abuse must be investigated by a State agency, and the local agency has determined this does not qualify. Accusations of criminal damage to property must be certain of who did it.

2. Request for approval to purchase a replacement blower for the Grit Removal Chamber at the Waste Water Treatment Plant.

Mayor Farley indicated this is a request to approve the purchase of a replacement blower for the Grit Removal Chamber at the Waste Water Treatment Plant. The Grit Removal Chamber is a necessary part of the process at the plant and the existing equipment is no longer functioning properly. Public Works has budgeted \$18,000 for the replacement. We have two bids for the replacement blower and recommend accepting the quote from Municipal Equipment in the amount of \$18,351.50 plus freight costs. Motion made by Councilwoman Crouch and seconded by Councilman Bringwald to approve the purchase of a replacement blower for the Grit Removal Chamber at the Waste Water Treatment Plant from Municipal Equipment in the amount of \$18,351.50 plus freight costs. I AM LOUIS DANIELS. MY WIFE AND I LIVE AT 327 E, BRYAN ST.

I AM HERE AS ADVOCATE FOR THREE FACTIONS:

- #1. FIRST AND FORMOST MYSELF, MY WIFE, AND OUR PROPERTY.
- #2. SECONDLY OUR NEIGHBORHOOD.
- #3. THIRDLY OUR POLICE DEPARTMENT.

BE IT KNOWN THAT WHATEVER HAS BEEN DONE TO US OR TO OUR PROPERTY OVER THE YEARS BY THE RESIDENTS OR THEIR ACQUAINTENCES FROM NEXT DOOR:

- #1. I HAVE NEVER RETALIATED.
- #2. I HAVE NEVER BEEN ARRESTED.
- #3. I HAVE NEVER BEEN ISSUED A CITATION.
- #4. I HAVE NEVER MADE FALSE ACCUSIATIONS TO THE POLICE.
- #5. I HAVE NEVER DENIED GUILT TO THE POLICE ON AN ACCUSIATION MADE AGAINST ME IF I WAS INDEED GUILTY OF THAT ACCUSIATION.

NOW I AM BEING 'WARNED' THAT IF I 'RESPOND' TO A SITUATION OR MAKE 'CONTACT', I COULD BE ISSUED A CITATION OR POSSABLY ARRESTED.

AS THE HEAD OF THE HOUSEHOLD AT 327 E. BRYAN ST., I AM RESPONSIBLE FOR PROTECTING MYSELF, MY FAMILY, AND OUR PROPERTY. BUT, BECAUSE WE ARE RESIDENTS OF THE CITY OF SALEM, I AM REQUIRED 'BY LAW' TO BE TOTALLY DEPENDENT UPON THE CITY OF SALEN POLICE DEPARTMENT FOR THAT PROTECTION. PROTECTION THAT PAST AND RECENT EVENTS SHOW CLEARLY, DOES NOT EXIST.

THIS MEANS THAT I HAVE NO LEGAL MEANS OF PROTECTING MYSELF, MY FAMILY, OR OUR PROPERTY. BECAUSE, THAT WHICH HAS HAPPENED TO US OVER THE YEARS AND RECENTLY IS NOT A CRIMINAL OFFENCE, JUST A PETTY VIOLATION, IT COULD HAPPEN OVER AGAIN AND AGAIN, AND IS STILL HAPPENING. IF YOU GET CAUGHT VIOLATING A CURRENT ORDINANCE, IT IS ONLY A \$75 FINE.

WE AND OUR PROPERTY HAS BEEN UNDER CONTINUAL ATTACK FOR THE PAST THIRTEEN YEARS. WE HAVE BEEN PLEADING FOR HELP FROM THE CITY OF SALEM FOR THE PAST TEN YEARS.

AUGUST 20, 2010, WE WERE ATTACKED WITH SEVERAL RAW EGGS BEING THROWN AT AND HITTING OUR HOUSE, OUR CAR, AND OUR CAR PORT.

IN THE MEANTIME THERE HAVE BEEN MANY ATTACKS.

JUNE 13, 2013, WE GAVE OUR "LETTER OF CONCERNS" TO THE POLICE DEPARTMENT; PLEADING FOR HELP.

IN THE MEANTIME THERE HAVE BEEN MANY ATTACKS.

AUGUST 18, 2022, I MET WITH THE SOON TO BE CHIEF OF POLICE; PLEADING FOR HELP.

JUNE 11, 2023, 12:00 MIDNIGHT, WE WERE ATTACKED BY A HUNK OF CONCRETE THROWN AT AND HITTING OUR HOUSE.

JUNE 29, 2023, 9:00PM WE WERE ATTACKED BY AN OBJECT HITTING OUR HOUSE HARD, FOLLOWED BY INTINSE HARASSMENT.

JULY 3, 2023, 1:00AM, WE WERE ATTACKED BY FIREWORKS BEING SHOT AT AND HITTING OUR HOUSE.

JULY 4, 2023, 1:00AM, AGAIN WE WERE ATTACKED BY FIREWORKS BEING SHOT AT AND HITTING OUR HOUSE.

JULY 4, 2023, 1:20AM, WE WERE ATTACKED BY ROCKS BEING THROWN AT AND HITTING OUR HOUSE, OUR CAR, OUR CAR PORT, AND ME.

THIS IS THE THIRTEEN YEARS THAT WE HAVE BEEN UNDER CONTINUAL ATTACK. COMING FROM OUR NEXT DOOR NEIGHBORS. THIRTEEN YEARS OF PRIVATE NUISANCE!

AUGUST 9,2023,10:00AM, I MET WITH SOME OF THE CITY OFFICIALS; PLEADING FOR AN END TO THESE CONTINUAL ATTACKS.

DECEMBER 18, 2023, 6:00PM, SALEM CYTY COUNCIL MEETING, STILL PLEADING BECAUSE THE ATTACKS HAVE NOT CEASED AND WILL NOT CEASE.

I HAVE BEEN TOLD BY THE POLICE, "THE ONLY WAY YOU AND YOUR WIFE CAN BE FREE FROM THE PEOPLE NEXT DOOR IS FOR YOU AND YOUR WIFE TO MOVE TO SOMEWHERE ELSE."

BARBARA AND I ARE RESPECTED MEMBERS OF OUR NEIGHBORHOOD. WE HAVE LIVED HERE FOR 54 YRARS. FOR THE FIRST 30 YEARS OF THOSE 54 YEARS THIS WAS A NICE CLEAN QUIET SAFE NEIGHBORHOOD. THEN THE PROPERTY NEXT DOOR SOLD AND THE NEIGHBORHOOD HAS NOT BEEN THE SAME NEIGHBORHOOD WE BOUGHT INTO.

AILING ELDERLY COUPLE ATTACKED IN THE MIDDLE OF THE NIGHT. THE CITY OF SALEM CAN NOT PROTECT THEM.

The attacks occurred on consecutive nights at exactly one o'clock in the morning of July 3rd and 4th, 2023. The elderly couple's home and property were deliberately and maliciously attacked with fifteen roman candles exploding directly over their house, eleven exploding rockets shot over and at the couple's house, some hitting the house, followed by rocks that were thrown at the elderly couple's car, carport, their house, and at the elderly man, some rocks hitting on all counts. All fireworks and rocks came from the next door neighbor's driveway.

THIS IS NO HOLIDAY CELEBRATION. NOT AT ONE O'CLOCK IN THE MORNING. NOT WITH THE THROWING OF ROCKS. THIS IS DELIBERATE HARASSMENT TO AN ELDERLY COUPLE. THERE WAS NOT A SINGLE PERSON FROM THE NEIGHBOR'S HOUSEHOLD WHO MADE ANY ATTEMPT AT STOPPING THE ATTACKS, EVEN THOUGH IT IS ON THEIR PROPERTY, THEY ARE GUILTY OF NOTHING BECAUSE THEY WERE ONLY SPECTATORS. THEY WERE ALL ENJOYING SOMEONE ELSE TORMENTING A HELPLESS OLD COUPLE IN THE MIDDLE OF THE NIGHT. HOW CAN THIS NOT BE AGAINST THE LAW FOR BOTH THE CULPRIT AND THE HOUSEHOLD? APPARENTLY IT IS LEGAL!

No arrest was made. No charges were filed for harassment or assault to the elderly couple, or for encroachment of their property. Why not? Because the City of Salem has NO LAWS, NO ORDINANCES, NO POLICIES in place to give our LAW ENFORCEMENT the POWER to protect the CITY'S CITIZENS with more than, "There is nothing we can do. Our hands are tied."

THE FOLLOWING STATEMENT IS PART OF THE 'NUISANCE PROPERTY' DEFINITION. 'ONE OF THE MANY BENEFITS OF OWNING PROPERTY IS THE RIGHT TO RESPONSABLY USE IT AS YOU PLEASE, HOWEVER THIS RIGHT IS NOT UNLIMITED.

THE NEXT DOOR PROPERTY OWNERS ARE USING ONLY THE PART, 'THE RIGHT TO USE THEIR PROPERTY AS THEY PLEASE' WITHOUT CONSIDERING OR CARING ABOUT THE PARTS, 'REASONABLY' OR 'THIS RIGHT IS NOT UNLIMITED'. AS LONG AS THEY ARE NOT BREAKING A 'CRIMINAL LAW' THEY DO NOT CARE HOW WHAT THEY DO AFFECTS OTHER PEOPLE, OTHER PEOPLE'S PROPERTY, OR THE NEIGHBORHOOD. WHAT THEY DO THAT NO ONE ELSE IN THE NEIGHBORHOOD DOES PROVES THIS.

THE DEFINITION OF 'NUISANCE PROPERTY' READS IN PART; 'THE USE OF ONE'S PROPERTY IN A MANNER THAT CREATES A SUBSTANTIAL, UNREASONABLE INTERFERENCE WITH THE USE OR ENJOYMENT OF ANOTHER PERSON'S PROPERTY, EVEN IF THE NUISANCE WAS CREATED BY SOMEONE ELSE.

I HAVE PROVIDED THE HISTORY, THE OVERALL APPEARANCE OF THE PROPERTY, THE LIFE STYLE, THE DISPICABLE THINGS, SAMPLES OF THE 200 PHOTOS, 100 VIDEOS, 250 POLICE REPORTS, AND 170 PIECES OF PHYSICAL EVIDENCE THAT SUBSTANTIATE THE GRIEVANCES. YOU ARE WELCOME TO CHALLENGE ANY OR ALL OF THE EVIDENCE.

I CAN PROVIDE YOU WITH CHARACTER TESTIMONY FROM CONCERNED NEIGHBORS AND FRIENDS AS TO HOW WE HAVE BEEN TREATED OVER THE YEARS BY THESE PEOPLE, MEDICAL RECORDS, OR A SIGNED PETITION IF YOU REQUIRE IT.

THESE ARE OUR GRIEVANCES. KEEP IN MIND THAT NO ONE ELSE IN THE NEIGHBORHOOD DOES THESE THINGS WHICH ARE:

- #1. The property is a perpetual 'eyesore' affecting the overall aesthetics of the neighborhood and therefore driving down the property values. Piles of junk, mattresses, and loose trash are strewn about the property.
- #2. The residents at this property and their acquaintances create a continual disruption in the everyday life of the neighborhood with their private and public disputes, yelling, cursing, in the yard and in the street.
- #3. Police calls to this property are exorbitant compared to all other properties in this neighborhood, these 'calls' also create a disruption to the everyday tranquility of the neighborhood.
- #4. Private Nuisance to the neighbors of this property and Public Nuisance to the neighborhood of which this property is a part by the constant running of 4-wheelers or such, with noise, smoke, fumes, clouds of dust, day and night, and for hours on end, in their own yard, in their neighbors yards, in the alley, and in the streets causing disturbances in the entire neighborhood. I have video on all of these allegations except noise.
- #5. Unleashed dogs from this property constantly roaming the neighborhood, in neighbor's yards, and disrupting neighborhood dogs which are contained within their own properties.
- #6. Unleashed dogs from this property which are urinating and pooping in other people's yards.
- #7. Constant yelling for the unleashed dogs from this property and from throughout the neighborhood causing disturbances to the neighbors and throughout the neighborhood.
- #8. Leashed dog urinating on and jumping on private property.
- #9. Encroachment to private property with trash, junk, and articles of all sorts.
- #10. Petty vandalism to private property.
- #11. Derelict van in back yard for two years which the police can not tow away.
- #12. Truck in the driveway unmoved for one year filled with junk and trash to overflowing which is a constant eyesore for the neighbors, the neighborhood, and passers by; all have to look at every day.

QUESTION: WHY ARE ALL THESE THINGS ALLOWED TO CONTINUE? ANSWER: BECAUSE THE CITY HAS NO ORDINANCES ADDRESSING MANY OF THESE OFFENCES WHICH ARE CONSIDERED PETTY AND ARE NOT (CRIMINAL OFFENCES) AND THE ORDINANCES THAT DO EXIST ARE ANTIQUATED AND HAVE NO CLOUT, THUS TYING THE POLICE OFFICERS HANDS SO THAT THERE IS NOTHING THEY CAN DO.

THE NEWSPAPER ARTICLE SAID I AM FRUSTRATED. CONSIDERING WHAT MY WIFE AND I HAVE ENDURED OVER THE YEARS AND PARTICULARLY RECENTLY, I HAVE EVERY RIGHT TO BE FRUSTRATED AND ANGRY.

MY WIFE IS LAYING ON THE COUCH IN AGONIZING PAIN AND HAS BEEN FOR FOUR MONTHS. TWO NIGHTS IN A ROW OF BEING BOMBARDED BY EXPLODING FIREWORKS HAS TRAMATIZED HER TO THE POINT THAT HER BLOOD PRESSURE HAS SPIKED TO THE LEVEL THAT HER DOCTOR CAN NOT SIGN OFF ON HER SPINE SURGERY UNTIL HOURS BEFORE THE SURGERY. YES, THIS UPSETE ME TREMENDOUSLY.

I GO OUT TO WAIT FOR THE POLICE TO SHOW UP TO BE GREETED WITH "HEY BITCH", TO BE FOLLOWED BY ROCKS BEING THROWN AT AND HITTING ME.

I HAVE AN UNDERSHIRT THAT IS STAINED WITH BLUE JELL FROM MY LIFE VEST AS A PRECURSER TO MY BEING ZAPPED BY THE DEFIBRILLATOR IN MY LIFE VEST.

I TOLD (SOME OF YOU) AT THE AUGUST 9TH MEETING THAT THESE JULY 3RD AND 4TH WEEKEND INCIDENTS WERE ALL I COULD TAKE FROM THESE PEOPLE, NO MORE! I HAVE TOLD THE POLICE OVER AND OVER THAT "THESE PEOPLE ARE NOT GOING TO STOP". THE POLICE TELL ME OVER AND OVER, "SORRY, THERE IS NOTHING WE CAN DO, OUR HANDS ARE TIED." THESE PEOPLE HAVE NOT STOPPED! THEY WILL NEVER STOP!

I DRIVE AROUND AND SEE THE STREETS WITH THEIR NICE HOMES AND NICE YARDS AND IMAGINE THE HOMEOWNERS COMING HOME EVERYDAY, SITTING ON THEIR PORCH SWING OR ON THEIR PADIO ENJOYING THEIR NICE CLEAN QUIET SAFE BLISSFUL NEIGHBORHOOD WITH NO NEIGHBORS ARGUING YELLING SCREAMING CURSING, (SHOOTING FIREWORKS AT THEIR HOUSE).

WHAT DO YOU GO HOME TO EVERY DAY?

WHEN IS ENOUGH, ENOUGH?

13 YEARS OF CONTINUAL HARASSMENT AND 150 POLICE CALLS TO A SINGLE RESIDENCE IS ENOUGH!

FINALLY, A QUOTE FROM (MOSE) THE AMISH GUY, "WHERE I COME FROM, WHEN SOMETHING NEEDS DOIN, YOU JUST DO IT."
